**SUBJECT:** Hospital Provider Enrollment for Priority COVID-  
19 Vaccine Distribution

Dear Colleagues,

Pfizer has recently applied for an Emergency Use Authorization with the FDA for their COVID-19 vaccine. Moderna will soon follow with an application for their COVID-19 vaccine. Early data for both vaccines are promising with initial reports of 90-95% effectiveness.

Approval of the EUA for the Pfizer vaccine is anticipated soon which will allow the Mississippi State Department of Health (MSDH) to obtain and position vaccine to be ready when the Advisory Committee on Immunization Practices (ACIP) releases the formal recommendations for vaccine administration.

The initial allocation of vaccine will likely be limited, **therefore the first priority for vaccination distribution and administration will be frontline hospital staff at highest risk of contact to COVID-19 infected patients.** As the allocations of vaccine increase, vaccine distribution will expand to additional priority groups.

**In order for your hospital to receive vaccine to administer to priority staff, your facility must be enrolled as a COVID-19 vaccine provider.** Your facility will need to complete the Provider Agreement paperwork and submit as soon as possible. Once processed, your organization will receive additional information for next steps. Facilities should first submit the enrollment agreement for their hospital prior to submitting an agreement for other facilities within your organization.

**Definition of Alerting Vocabulary and Message Specification Settings**

**Originating Agency:** A unique identifier for the agency originating the alert.

**Alerting Program:** The program sending the alert or engaging in alerts and communications using PHIN Communication and Alerting (PCA) as a vehicle for their delivery.

**Message Identifier:** A unique alert identifier that is generated upon alert activation (MSHAN-yyymmdd-hhmm-TTT (**ALT=Health Alert**, **ADV=Health Advisory**, **UPD=Health Update**, **MSG/INFO=Message/Info Service**)).

**Program (HAN) Type:** Categories of Health Alert Messages.

**Health Alert:** Conveys the highest level of importance; warrants immediate action or attention.

**Health Advisory:** Provides important information for a specific incident or situation; may not require immediate action.

**Health Update:** Provides updated information regarding an incident or situation; unlikely to require immediate action.

**Health Info Service:** Provides Message / Notification of general public health information; unlikely to require immediate action.

**Status (Type):**

- Actual: Communication or alert refers to a live event
- Exercise: Designated recipients must respond to the communication or alert
- Test: Communication or alert is related to a technical, system test and should be disregarded



**Message Type:**

Alert: Indicates an original Alert  
Update: Indicates prior alert has been Updated and/or superseded  
Cancel: Indicates prior alert has been cancelled  
Error: Indicates prior alert has been retracted

**Reference:** For a communication or alert with a Message Type of “Update” or “Cancel”, this attribute contains the unique Message Identifier of the original communication or alert being updated or cancelled. “n/a” = Not Applicable.

**Severity:**

Extreme: Extraordinary threat to life or property  
Severe: Significant threat to life or property  
Moderate: Possible threat to life or property  
Minor: Minimal threat to life or property  
Unknown: Unknown threat to life or property

**Acknowledgement:** Indicates whether an acknowledgement on the part of the recipient is required to confirm that the alert was received, and the timeframe in which a response is required (Yes or No).

**Sensitive:**

Sensitive: Indicates the alert contains sensitive content  
Not Sensitive: Indicates non-sensitive content

**Message Expiration:** Undetermined.

**Urgency:** Undetermined. Responsive action should be taken immediately.

**Delivery Time:** Indicates the timeframe for delivery of the alert (15, 60, 1440, 4320 minutes (.25, 1, 24, 72 hours)).
