

The MDE, through the Office of Early Childhood, is offering two Online Early Childhood Self-Paced Training Courses for the novice and veteran administrators from February 19, 2024, through March 29, 2024. These online self-paced trainings will provide novice and veteran administrators who oversee pre-K classrooms with a plethora of knowledge around early learning best practices.

These online self-paced courses are being offered to:

- <u>Novice Administrators</u> with one (1) to three (3) years of early childhood experience – The completion of this online training program includes completion of all modules, assessments, and a course survey.
- <u>Veteran Administrators</u> with three (3) or more years of experience The completion of this online training program includes completion of all modules, assessments, and a course survey.

The online self-paced courses can accommodate up to sixty (60) participants each. Registration will be on a first-come-first-

serve basis at <u>https://gsmu.mdek12.org/public/course/browse</u>. 1.5 CEUs, 10 SEMIs, 1 OSL, and 10 Contact Hours will be offered when participants complete all requirements for this course.
