Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule: [The Department of Health finds that Certificates of Need \(CONs\) have been issued to serve unmet healthcare needs of the state and that compliance with the Attorney General’s Opinion of October 12, 2007, may prevent the completion of outstanding CONs that were issued to address such needs. Changes in the CON Rules regarding extension of valid CONs are necessary to comply with the Attorney General’s Opinion, to modify requirements for six-month extensions, to clarify the status of incomplete CONs, and to provide transition of incomplete CONs.](#)
