








Indicator 3-A1: Early Childhood Outcomes Public Health Districts Data for FFY 2016






Indicator 3-B1: Early Childhood Outcomes Public Health Districts Data for FFY 2016






Indicator 3-A2: Early Childhood Outcomes Public Health Districts Data for FFY 2016






Indicator 3-B2: Early Childhood Outcomes Public Health Districts Data for FFY 2016










Indicator 4B: Family Outcomes Public Health District Data for FFY 2016




